## Packaging Industry in Transition Innovation, Sustainability and Emerging Careers

The global packaging industry is undergoing rapid transformation as sustainability pressures and advances in automation and production technologies reshape the sector. The global packaging market is projected to grow from USD 1.28 trillion in 2025 to USD 1.69 trillion by 2034, registering a CAGR of 3.16%. Asia is leading this growth, with India emerging as a major hub, where the industry is expected to expand from USD 84 billion in 2024 to USD 143 billion by 2029, at a CAGR of 11%, driven by the rise of e-commerce and demand for packaged goods.

Packaging materials include paper and paperboard, plastics, metal, glass and biodegradable materials, with plastics accounting for nearly 40–45% of the global packaging market due to their versatility and cost-effectiveness. Materials such as polyethylene, polypropylene and PET remain widely used, and the plastic packaging segment is projected to grow at 4–5% CAGR.

At the same time, sustainability challenges are fundamentally changing the industry. Demand for recycled plastics, particularly recycled PET (rPET), is rising and expected to grow at 6–7% CAGR, supported by circular economy initiatives and stricter environmental regulations. However, the relatively low share of recycled plastics in overall packaging is accelerating the search for recyclable designs, bioplastics and plant-based materials.

Parallely, the adoption of automation, smart manufacturing, advanced printing, and digital production technologies is transforming packaging design, production and supply chains. These shifts are creating a strong demand for new skill sets in sustainable materials, packaging engineering, automation systems and digital manufacturing, requiring the industry to invest in skill upgrades and nurture a new generation of trained packaging professionals to meet future demands.

### Bridging the Skills Gap through Innovation and Training

The increasing integration of automation, sustainability, and digital technologies in packaging production is also creating a significant skills gap in the industry. As companies adopt automated packaging lines and advanced manufacturing systems, there is rising demand for professionals such as automation engineers, robotics technicians, and system integrators to manage and maintain these technologies.

At the same time, the shift toward environmentally responsible packaging is generating strong demand for sustainability specialists. It is estimated that nearly 25,000 professionals will be needed in areas such as Life Cycle Assessment (LCA), sustainable



packaging design, recyclable and compostable materials, and waste reduction strategies to support circular economy practices.

The growing use of smart packaging, IoT, data analytics, and Artificial Intelligence (AI) is further transforming packaging into a data-driven industry, increasing demand for experts in digital manufacturing, machine learning, and intelligent supply chain management. Alongside this, innovation in biodegradable materials, bio-based plastics, and eco-friendly barrier technologies is opening new research and development opportunities.

Addressing these emerging needs will require stronger collaboration between industry, academia, and research institutions, along with specialised training in automation, AI, and sustainable packaging technologies to build a future-ready workforce.

### Employment Projection and Salary Trends

The next-generation workforce will be a key to driving the packaging industry forward, ensuring it remains competitive and resilient in the face of technological change and environmental challenges. The packaging sector offers dynamic employment opportunities across five primary domains:

- Packaging Design and Development
- Innovative Packaging Materials Manufacturing and Operations
- Techno-Commercial Roles (Sales and Marketing)
- Packaging Logistics and Supply Chain
- Biodegradability, Sustainability and Compliance
- AI Application and IoT
- Quality Assurance and Management
- Digitalisation of Packaging Labels
- Smart Labelling and Active Packaging Systems
- Robotics, Packaging Automation and End of Line Solution
- Life Cycle Analysis and Carbon Mapping

- Machine Manufacturing and Packaging Converting
- Packaging User Industry and Product Packaging

Salaries in the Indian packaging industry vary by specialisation and experience. Entry-level roles offer INR 5,00,000–6,00,000 annually, mid-level engineers and specialists earn between INR 8,00,000–15,00,000, and senior managers can exceed INR 20,00,000 per annum. The industry's cross-sector relevance offers opportunities for lateral movement and global exposure. The workforce in the packaging sector is expected to grow by 6–7% annually, with specific roles seeing significant increases in demand:

- Packaging Machine Operators: +45,000 jobs globally by 2026
- Packaging Engineers and Designers: +20,000 jobs globally by 2026
- Sustainability Consultants: +10,000 jobs globally by 2026
- Packaging Line Workers: +80,000 jobs globally by 2026

### Manpower Breakdown and Roles in Key Segments

1. **Production, Manufacturing and Operations**
  - **Machine Operators, Assembly Line Workers, and Maintenance Technicians:** With the increasing adoption of automation and robotics, there is a growing need for skilled operators and maintenance technicians. Over the next three years, the packaging industry will require an estimated 50,000 new machine operators to handle automated production lines.
  - **Packaging Line Workers:** As E-commerce and rapid production demands rise, the need for packaging line workers will grow. By 2026, the industry will need 80,000 additional line workers to ensure production efficiency.
  - **Operations Managers:** Operation managers are responsible for planning, coordinating, and supervising manufacturing activities

to meet production targets, manage resources, and drive continuous improvement.

### 2. Research & Development (R&D) and Design

- **Packaging Designers and Engineers:** Sustainability is a key driver in packaging design. By 2026, the packaging sector will require an additional 30,000–40,000 packaging designers and engineers focused on eco-friendly and innovative packaging solutions.
- **Sustainability Experts:** With heightened focus on reducing packaging waste and using recyclable materials, 10,000–15,000 sustainability experts will be needed over the next 5 years.
- **Software/Automation Engineers:** As packaging systems increasingly integrate automation and smart technology (e.g., QR codes, freshness indicators), software and automation engineers will play a critical role in embedded systems design and manufacturing line automation.



- **Quality Control/Testing Engineers:** To ensure packaging performance, safety, and regulatory compliance, quality control and testing engineers are essential for validating materials, structural integrity, and shelf-life requirements.

### 3. Logistics and Supply Chain

- **Packaging Logistics Managers:** The growth of packaging logistics, especially in e-commerce, will demand an 8% annual increase in packaging logistics managers, leading to a substantial increase in the workforce.
- **Supply Chain Analysts:** With the integration of smart technologies in supply chains, the packaging industry will need an additional 15,000 supply chain analysts by 2026.
- **Customs and Compliance Specialists:** They manage import/export documentation and ensure compliance with international trade laws, customs regulations, and packaging standards for cross-border logistics.

**4. Sustainability and Compliance**

- **Regulatory Compliance Officers:** These focus on ensuring that the company's operations align with environmental, social, and economic sustainability goal, including environmental laws and product standards.
- **Sustainability Consultants:** These are external experts or specialists helping organisations adopt green technologies and practices.
- **Health & Safety Managers:** These ensure compliance with safety protocols and create a healthy working environment.
- **Business Development Managers:** They focus on

- identifying new market opportunities and client engagement.
- **Sales Engineers/Executives:** They link technical features of products with customer needs.
- **Product Managers:** These oversee the commercial and technical aspects of products, working with both engineering and marketing teams.
- **Marketing and Communications:** They often manage product positioning, branding, and promotion.

As packaging industries adopt automation, robotics, and digital monitoring systems, the integration of AI and ML is becoming essential for improving productivity and ensuring consistent product quality.

A career in AI and ML within packaging technology offers emerging opportunities for professionals who can combine data science skills with knowledge of packaging processes and materials.

Experts in this area can work on developing intelligent packaging systems, smart manufacturing lines, and data-driven solutions for sustainability and waste reduction. With the packaging sector rapidly adopting Industry 4.0 technologies, there is growing demand for professionals skilled in AI-based analytics, automation, and digital manufacturing, making this an important and future-oriented career pathway in the packaging industry.



### President Appoints New Governors for Several States

President Smt. Droupadi Murmu has appointed new Governors for several States and Union Territories. The Governor of Himachal Pradesh, Shri. Shiv Pratap Shukla, has been appointed as Governor of Telangana. The Governor of Telangana, Shri. Jishnu Dev Varma, has been appointed as Governor of Maharashtra. Former Speaker of the Bihar Legislative Assembly, Shri. Nand Kishore Yadav, has been appointed as Governor of Nagaland, while Lieutenant General (Retd.) Syed Ata Hasnain has been appointed as Governor of Bihar. The Governor of Tamil Nadu, Shri. R. N. Ravi, has been appointed as Governor of West Bengal. The Governor of Kerala, Shri. Rajendra Vishwanath Arlekar, will discharge the functions of the Governor of Tamil Nadu. The President has accepted the resignation of Shri. C. V. Ananda Bose as Governor of West Bengal. The Lieutenant Governor of Ladakh, Shri. Kavinder Gupta, has been appointed as Governor of Himachal Pradesh. The Lieutenant Governor of Delhi, Shri. Vinai Kumar Saxena, has been appointed as Lieutenant Governor of Ladakh. Former diplomat Shri. Taranjit Singh Sandhu has been appointed as the Lieutenant Governor of Delhi.

### India, Canada Launch CEPA Talks during Canada PM's Visit



Canadian Prime Minister Mr. Mark Carney visited India from February 27 to March 2, during which the two countries launched negotiations for a Comprehensive Economic Partnership Agreement (CEPA). The Terms of Reference for the agreement were signed by India's Commerce and Industry Minister Shri Piyush Goyal and Canada's International Trade Minister Shri Maninder Sidhu at Hyderabad House in New Delhi, in the presence of Prime Minister Shri Narendra Modi and Prime Minister Mr. Mark Carney. The two countries aim to increase bilateral trade to 50 billion dollars by 2030 and unlock the full potential of economic cooperation by concluding the CEPA soon. Both sides also discussed strengthening cooperation in trade, investment, energy, technology, and critical minerals to further deepen bilateral ties.

### Digital Tools for Upcoming Census 2027 Launched

Union Home Minister Shri Amit Shah, on March 5, soft-launched four digital tools and unveiled the mascots *Pragati* and *Vikas* for the upcoming Census 2027. The digital tools include the House Listing Block (HLB) Creator Web Application, the House Listing Operation (HLO) Mobile Application, the Self-Enumeration (SE) Portal, and the Census Management and Monitoring System (CMMS) Portal. These platforms have been developed by the Centre for Development of Advanced Computing to support census operations across the country. The government notified its intent to conduct the census through a Gazette notification issued on June 16 last year, formally starting the census process. The census will be conducted in two phases and is expected to be the world's largest population enumeration exercise till date. For the first time, the census will be conducted digitally, with citizens also getting the option of self-enumeration. The mascots, *Pragati* and *Vikas*, symbolise the equal participation of women and men in achieving the vision of a developed India by 2047.

### Publications Division Releases 16 Books on Tamil Heritage

The Publications Division of the Ministry of Information and Broadcasting released 16 books on Tamil scholars, heritage, architecture and culture in New Delhi on March 5. The books were launched by Vice President Shri. C. P. Radhakrishnan in the presence of Information and Broadcasting Minister Shri. Ashwini Vaishnav and Minister of State Shri. L. Murugan and other dignitaries. Of the total titles, 14 are in Tamil. The publications cover diverse themes including heritage sites, literature, music, agriculture and science. Some of the titles include works on Rameswaram Temple, Ramanuja, Madurai Meenakshi Amman Temple and Brihadisvara Temple, along with books on Tamil devotional literature, traditional musical instruments and rural traditions. Among the key releases is a book on Bankim Chandra Chatterjee by Shri. S. K. Bose, brought out in English, Hindi and Tamil to mark the 150th anniversary of *Vande Mataram*.



## ECONOMY

### Govt. Assures Citizens of Energy Supply and Affordability Amid West Asia Tensions

Amid rising tensions in West Asia and shifting global energy dynamics, the Government of India has assured citizens that energy supplies remain secure and affordable. According to the Ministry of Petroleum and Natural Gas, the country has diversified its energy sources and maintains adequate reserves to handle potential disruptions. The Ministry noted that India is the world's third-largest importer, fourth-largest refiner, and fifth-largest exporter of petroleum products. It added that the country has sufficient stocks of crude oil and key fuels such as petrol, diesel, and aviation turbine fuel to manage short-term supply challenges. To closely track the situation following disruptions in the West Asian region, the ministry has set up a 24x7 control room to monitor petroleum supply and stock levels nationwide and protect consumer interests.

### UN Hails Pradhan Mantri Jan Dhan Yojana as Model for Women's Inclusion

The United Nations has praised India's *Pradhan Mantri Jan Dhan Yojana* (PMJDY) as a global model for women's financial inclusion. Speaking ahead of the 70th session of the Commission on the Status of Women, Ms. Sandra Hendriks, Policy Director at UN Women, said the scheme has transformed access to banking for women. Powered by the Aadhaar digital identity system, the programme has enabled more than 290 million women to open bank accounts. Hendriks described digital financial inclusion as essential for empowering women and noted that reforms in India have reduced barriers to opening bank accounts and starting businesses. She said the initiative demonstrates how policy measures can significantly advance women's economic participation. Launched in 2014, the scheme has opened over 56 crore bank accounts, with women holding around 56 percent of them and nearly two-thirds located in rural and semi-urban areas. The programme is linked with the Jan-Dhan-Aadhaar-Mobile (JAM) Trinity, which supports direct benefit transfers for welfare schemes.

### Nepal Votes in First Election After Youth-Led Protests



Nepal held general elections on March 5, 2026 to elect the 275-member House of Representatives, marking the first national polls since Gen Z-led protests toppled the previous government. Voting concluded peacefully with around 60 per cent turnout among nearly 19 million eligible voters. The election followed months of youth protests against corruption and economic hardship, which led to the resignation of former Prime Minister Shri K. P. Sharma Oli and the appointment of interim Prime Minister Smt. Sushila Karki. Polling was held in 165 constituencies under tight security, though difficult terrain in remote regions delayed the transport of some ballots. Major contenders include Oli's Communist Party of Nepal (Unified Marxist-Leninist), Shri Sher Bahadur Deuba's Nepali Congress, Shri Pushpa Kamal Dahal's Communist Party of Nepal (Maoist Centre), and the youth-backed Rastriya Swatantra Party led by Shri Balendra Shah.

### Sports Ministry Unveils Logo of Cycling League of India

Union Youth Affairs and Sports Minister Shri Mansukh Mandaviya unveiled the logo of the world's first franchise-based road cycling competition, the Cycling League of India on March 5. Describing the initiative as a transformative step for cycling in the country, the Minister said the league will build on the momentum created by recent professional cycling events and inspire young people to take up the sport. The upcoming league will feature eight city- or region-based franchises, each comprising ten cyclists. Each team will include two international riders to bring global experience and two junior cyclists to promote emerging Indian talent and ensure long-term development of the sports.
