## Mission Karmayogi

### What It Means for India's Future Civil Servants

India today stands at an important moment in its development journey. The country has articulated an ambitious national vision of becoming a developed nation by the year 2047, marking one hundred years of independence. Achieving the goals of *Viksit Bharat 2047* will require sustained economic growth, strong institutions, and effective governance across sectors such as infrastructure, healthcare, agriculture, digital economy, and social welfare. At the heart of this transformation lies a crucial question: Do our public institutions and the officials who run them possess the capabilities required to manage the complex challenges of the twenty-first century?

Recognising the central role of competent public officials in national development, the Government of India launched *Mission Karmayogi*, formally known as the National Programme for Civil Services Capacity Building, in 2020. The initiative represents a systemic effort to strengthen the capabilities of India's public officials to meet the demands of modern governance. For young Indians aspiring to become civil servants, understanding *Mission Karmayogi* offers a valuable insight into how the expectations from future civil servants are changing.


To appreciate the significance of the mission, it is useful to understand the context in which it was introduced. India's administrative system is one of the largest in the world, with lakhs of public officials working across the Union and State Governments and local bodies. These officials are responsible for designing and implementing policies that affect the lives of over 140 crore citizens on a daily basis. At the same time, the nature of governance itself has been undergoing rapid change.

Advances in artificial intelligence and other emerging technologies are transforming how governments design and deliver services. Citizens are increasingly connected and informed, and they expect public services to be transparent, efficient, and responsive. Development challenges are becoming more complex and interconnected. Issues such as climate resilience, digital regulation, urbanisation, and economic competitiveness require coordinated responses across multiple institutions.

For example, India's Aspirational Districts Programme has demonstrated how data driven governance and continuous monitoring can improve development outcomes in districts that were historically underserved. Similarly, the success of Digital Public Infrastructure such as Aadhaar and the Unified Payments Interface (UPI) has shown how technological innovation can dramatically expand access to public services and financial inclusion. The rollout of Direct Benefit Transfer (DBT) system has also highlighted the importance of administrative capacity in delivering welfare benefits efficiently and reducing leakages.

These examples underline a simple but powerful insight - policies and programmes succeed when public officials possess the skills and tools required to design and implement them effectively. Strengthening the capabilities of civil servants therefore becomes an essential component of governance reform.

Traditionally, civil servants in India received training at the beginning of their careers and through occasional mid-career programmes. While these training initiatives played an important role, they often functioned as isolated events rather than part of a continuous learning



ecosystem. In a rapidly changing policy environment, this approach had significant limitations.

*Mission Karmayogi* seeks to address this challenge by transforming the way civil servants learn and develop throughout their careers. The mission envisions a shift from episodic training to continuous capacity building, where public officials can update their knowledge and skills regularly as the demands of governance evolve.

A key feature of this reform is the introduction of a competency-based capacity building framework. In simple terms, competencies refer to the knowledge, skills, and behaviours required for performing a particular role effectively. Instead of offering generic training programmes, the new approach identifies the specific competencies required for different roles in government and aligns learning opportunities accordingly.

Under this framework, competencies are broadly categorised into three groups:

- **Domain competencies** relate to expertise in specific sectors such as finance, agriculture, health, or infrastructure.
- **Functional competencies** refer to administrative abilities such as project management, policy analysis, or financial management.
- **Behavioural competencies** include leadership, communication, ethical conduct, and the ability to work collaboratively.

This shift reflects a deeper change in how the role of civil servants is understood. In earlier decades, public administration often focused on regulatory oversight and procedural compliance. Today, civil servants are expected to function as problem solvers, policy designers, and facilitators of development. They must interpret data, engage with stakeholders, coordinate across departments, and adapt quickly to emerging challenges.

Consider the example of the Swachh Bharat Mission, where large scale behavioural change campaigns and community participation played a major role in improving sanitation outcomes. Similarly, initiatives such as CoWIN during the COVID-19 vaccination drive required public officials to combine technological systems, logistical planning, and citizen engagement at an unprecedented scale. Such experiences highlight how modern governance increasingly requires analytical thinking, technological literacy, ethical decision making, and effective communication.

*Mission Karmayogi* aims to nurture these competencies among civil servants through a structured and continuous learning ecosystem. One of the most important innovations introduced under the mission is the *iGOTKarmayogi* digital platform.

iGOT, which stands for Integrated Government Online Training, serves as a digital learning platform for public officials across India. The platform hosts courses, learning modules, and knowledge resources developed by training institutions, universities, and subject experts. Civil servants can access these resources online and pursue learning opportunities that are relevant to their current roles and future responsibilities. The platform makes learning more flexible and accessible. Instead of relying

only on classroom-based training programmes, officials can engage with learning materials whenever required. So far, over 1.5 crore public officials have already been onboarded on iGOT and it has witnessed over 8 crore course completions across over 4500 competency-linked courses. Over time, iGOT will become the backbone for a culture of continuous professional development within the civil services.

*Mission Karmayogi* is also supported by an institutional framework designed to guide and implement the reform. The Capacity Building Commission plays a key role in driving the competency-based approach, coordinating with central Ministries, Departments and States, and strengthening the overall capacity building ecosystem of the government. The digital infrastructure, including the *iGOTKarmayogi* platform, is managed by *Karmayogi Bharat*, which operates and expands the learning ecosystem for public officials.

Together with civil service training institutions and departmental capacity building units, these institutions form an integrated system aimed at supporting the professional development of civil servants across their careers.

For future civil servants, *Mission Karmayogi* is an important topic to understand not only because it

represents a major governance reform, but also because it reflects the evolving expectations from future public servants. More importantly, the mission signals a broader transformation in how public service is being envisioned in India. The government is seeking to build a civil service that is technologically capable, ethically grounded, and responsive to citizens' needs. For young aspirants, this points to the broader preparation required for public service: developing the ability to think analytically, learn continuously, and approach governance with a deep sense of responsibility toward citizens.

Understanding initiatives such as Mission Karmayogi helps aspirants appreciate how governance systems evolve over time. It also encourages them to align their mindset with the emerging demands of public administration in a rapidly changing world. In many ways, Mission Karmayogi represents a deeper shift in how India imagines the role of its public institutions and the people who lead them. As the country works towards the vision of *Viksit Bharat 2047*, the effectiveness of governance will increasingly depend not only on policies or budgets, but on the capabilities, judgement, and integrity of those who implement them.

For young Indians aspiring to join public service, this is an important signal. The civil servant of the future will not simply be an administrator of rules, but a learner, a problem solver, and a steward of public trust. For aspirants, therefore, understanding Mission Karmayogi is about recognising the kind of public service India seeks to build and the role that the next generation of civil servants will play in shaping India's journey towards *Viksit Bharat 2047*.

- (d) Selected candidates will be informed of his selection after completion of selection process and no correspondence in this regard will be entertained.
- (e) **Date of Examination:** Exact date, time and venue of examination will be communicated in the Call letter.
- (f) **Appointment Letter:** The appointment of provisionally selected candidates will be strictly, based on satisfaction of document verification, Medical Examination and other requirements as specified by the Government of India.





## NATIONAL

### ECI Announces Assembly Poll Dates for Four States, One UT

#### Polling Dates for Assembly Elections 2026

Kerala	April 9
Assam	April 9


The Election Commission of India (ECI), led by Chief Election Commissioner Shri Gyanesh Kumar, has announced the schedule for the 2026 Assembly elections across four states and one Union Territory, covering 824 constituencies. Polling will be held on April 9 in Kerala, Assam, and Puducherry; on April 23 in Tamil Nadu; and in two phases on April 23 and 29 in West Bengal. Counting of votes will take place on May 4. Around 17.4 crore voters are expected to participate, supported by over 2.19 lakh polling stations and nearly 25 lakh officials. West Bengal has the largest electorate, followed by Tamil Nadu, Kerala, Assam, and Puducherry. The Model Code of Conduct came into force immediately after the announcement, regulating political activities and government decisions from March 15 onwards. Alongside the main polls, by-elections will be held in eight constituencies across six other states. Voting for these by-polls will be held on April 9 in Goa, Karnataka, Nagaland, and Tripura, and on April 23 in Gujarat and Maharashtra, with counting also on May 4.

### Govt. Announces RELIEF Scheme to Support Exporters Amid West Asia Disruptions

The Government has approved a new support measure called RELIEF (Resilience & Logistics Intervention for Export Facilitation) to help exporters facing rising costs and uncertainty due to disruptions in West Asia's maritime routes. The move comes as security concerns around the Strait of Hormuz have led to longer shipping routes, congestion, and higher freight and insurance costs. Under the scheme, exporters will receive enhanced risk coverage and financial support. Shipments made during the disruption period will get up to 100% additional risk cover, while future exports over the next three months can avail up to 95% coverage with government backing. The scheme also includes partial reimbursement—up to Rs. 50 lakh—for MSME exporters who faced higher logistics costs without insurance coverage. The initiative, backed by Rs. 497 crore, aims to protect export flows, prevent order cancellations, and support jobs in export sectors.

### India-China to Resume Trade via Shipki La Pass

India and China will resume border trade through the Shipki La Pass in Himachal Pradesh's Kinnaur district from June 1, 2026, ending a six-year suspension caused by COVID-19 and border tensions. The decision follows a bilateral agreement reached in August 2025. Trade will run seasonally from June 1 to November 30 and will be limited to local traders from Pooh using a barter system. Imports will include items like wool, pashmina, salt, carpets, and herbal medicines, while exports will feature grains, spices, dry fruits, and handicrafts. The pass, located along the Sutlej River route from Tibet, has historically been a key trade link since its reopening in 1992 after the 1962 war. Trade volumes had previously reached as high as Rs. 59 crore in 2017, benefiting several border villages. The reopening complements similar trade routes at Lipulekh and Nathu La.

*Sadhu* by Shri Devabrat Das and *Dwngnwi Lama Mwnse Gathwi* by Shri Sahaisul Brahma have been adjudged the best novels in Assamese and Bodo, respectively. In poetry, *Shrestha Kabita* by Shri Prasun Bandyopadhyay, *Bhatkhadaki* by Shri Yogesh Vaidya, and *Animesha* by Shri Nandini Sidha Reddy have been adjudged the best works in their respective languages. In short stories, *Dada Seerisu Tande* by Shri Amaresh Nugadoni and *Safety Kit* by Shri Jinder have been adjudged the best collections. *Thamiz Sirukathaiyin Thadangal* by Shri. Tamilselvan has been adjudged the best work of literary criticism, while *Kalyaniya Resha* by Shri Raju Baviskar has been adjudged the best autobiography. *Dhatri Paat San Gaam* by Shri Mahendra has been adjudged the best memoir in Maithili. Each award carries a cash prize of Rs. 1 lakh, a shawl and a copper plaque.

## ECONOMY

### Cabinet Approves New Era of Industrial Development through BHAVYA

The Union Cabinet has approved the *Bharat Audyogik Vikas Yojana (BHAVYA)* with an allocation of Rs. 33,660 crore to set up 100 plug-and-play industrial parks across the country. Designed to accelerate manufacturing and attract investments, the scheme will generate large-scale employment by offering ready infrastructure and faster clearances. The initiative aims to strengthen India's position as a global manufacturing hub and create job opportunities nationwide.

### Small Hydro Power Scheme to Boost Energy Security in Remote, Hilly Regions

The Union Cabinet, chaired by Prime Minister Shri Narendra Modi, has approved the Small Hydro Power Development Scheme (2026-31) with an outlay of Rs. 2,584.60 crore. Targeting 1,500 MW capacity in remote and hilly regions, the scheme is expected to attract Rs. 15,000 crore investment and generate around 51 lakh person-days of employment. With central financial assistance up to Rs. 3.6 crore per MW in border areas, the initiative aims to promote eco-friendly power and rural livelihoods. Information Minister Shri Ashwini Vaishnaw termed it a major clean energy and employment booster.

## INTERNATIONAL

### India Speeds Up Evacuation of Stranded Citizens from West Asia



India continues its evacuation efforts under *Operation Sindhu 2026* to bring back stranded citizens from West Asia amid tensions between Iran and Israel. The Ministry of External Affairs (MEA) is coordinating special flights and land routes through Jordan, Egypt and Armenia, while embassies are relocating Indians from sensitive areas such as

Tehran. Control rooms and 24x7 helplines remain active to assist citizens. A key focus of the operation is on nearly 23,000 Indian seafarers stranded across the region, many of whom are aboard vessels affected by route disruptions, port restrictions and rising security risks. Authorities are working with shipping companies and host nations to ensure safe docking, crew changes and evacuation where required. An inter-ministerial task force, involving multiple agencies and state governments, is overseeing the process, with priority also given to students and vulnerable groups. As of March 19, around 2.44 lakh Indians have returned home since late February when the conflict started.

## SPORTS

### India Tops Para Athletics Grand Prix with 208 Medals

India dominated the World Para Athletics Grand Prix 2026 (New Delhi leg), finishing at the top of the medal table with 208 medals, including 75 gold, at the Jawaharlal Nehru Stadium. Russia finished second with 35 medals, while Bosnia and Herzegovina secured third place. The three-day event saw participation from 257 athletes across eight nations. Among standout performers, Preeti Pal won her second gold in the women's 200m, while Shubham Juyal clinched gold in shot put with a 14.45m throw. Rakeshbhai Bhatt and Manojkumar Sabapathi also secured top podium finishes, contributing to multiple Indian sweeps. Paralympic champions Sumit Antil and Praveen Kumar also added golds, highlighting India's strong performance. The event, part of the 13th Grand Prix season, also served as a key qualifier for upcoming global competitions including the World Para Athletics Championships and the 2028 Los Angeles Paralympics.

### BCCI Honours Cricket Stars at Naman Awards 2026



The Board of Control for Cricket in India (BCCI) hosted the Naman Awards 2026, celebrating top performers and legends of Indian cricket. Lifetime Achievement honours were given to Shri Roger Binny and Shri Rahul Dravid, while Ms Mithali Raj received the women's lifetime award. Among current stars, Shri Shubman Gill won the Best International Cricketer (Men) award, and Ms Smriti Mandhana took the women's honour. The ceremony also felicitated India's World Cup-winning teams.
