Big Markets, Bigger Dreams

How 'Womaniya' is Changing the Game

Are you a woman looking to start a business of your own? Or perhaps you already run a small enterprise or are part of a Self-Help Group, wondering how to reach more customers beyond your local area? If so, you need to know the following facts:

- The Government has created easier pathways for women to connect directly with one of the largest buyers in the country: the Government itself.
- Launched in 2019 by the Ministry of Commerce and Industry, the Womaniya initiative aims to make public procurement more inclusive by enabling women entrepreneurs—especially those from micro and small enterprises and SHGs—to access the formal government marketplace.
- By addressing challenges such as limited market access, low visibility and dependence on intermediaries, the initiative uses digital tools and simplified processes to make participation easier and more transparent.
- At the heart of this effort is the Government e-Marketplace (GeM), an online platform where government departments procure goods and services.
- Womaniya builds on this platform by providing a more accessible and supportive entry point for women entrepreneurs, helping them connect directly with government buyers and expand their businesses with confidence.

From Local Efforts to National Reach

Across India, lakhs of women are already running small but meaningful businesses. Some are weaving beautiful handloom textiles, others are creating handicrafts, décor items and practical products used in everyday life across households and establishments. Many of these women are part of Self-Help Groups (SHGs), where they come together not just to save money, but to support each other and grow as entrepreneurs.

Today, more than 11 crore women are connected through nearly 95 lakh SHGs. That is a huge network of skill, creativity and hard work. Yet, for a

long time, most of these products remained limited to local markets—village haats, nearby towns or small exhibitions. The challenge was never about quality or effort, but about reaching the right buyers at the right scale.

This is exactly where Womaniya makes a difference. By bringing women entrepreneurs onto the Government e-Marketplace (GeM), the initiative opens up a much larger marketplace. Instead of depending only on local demand, women can now showcase their products to government departments across the country.

In simple terms, a product made in a small village can now find a buyer sitting in a government office hundreds of kilometres away. This shift - from local selling to national-level access - not only increases income opportunities but also gives women entrepreneurs greater confidence to expand and improve their businesses.

SWAYATT: Expanding Opportunities through Inclusive Procurement

Womaniya is part of the SWAYATT (*Startups, Women and Youth Advantage Through e-Transactions*) initiative under the Government e-Marketplace (GeM) that aims to

support startups, young entrepreneurs, women-led enterprises, micro and small businesses, Self-Help Groups (SHGs) and other under-represented sections.

The idea is simple: make it easier for these groups to do business with the Government. This is achieved by reducing entry barriers, simplifying processes and providing training and support so that even first-time sellers can confidently participate.

Within this broader vision, Womaniya serves as a dedicated initiative for women entrepreneurs. It builds on the goals of SWAYATT by creating a more supportive and accessible space for women-led enterprises to connect with government buyers.

A Wide Range of Opportunities

One of the most practical aspects of Womaniya is that it builds on what women are already doing well.

Across the country, women entrepreneurs have developed strong skills in certain areas over the years - often rooted in local traditions, community knowledge and everyday needs. Womaniya recognises this and focuses on product categories where women already have both experience and confidence.

These include handicrafts, handloom textiles, grocery and pantry items,

office accessories and personal care products. What makes this approach effective is that women do not have to start from scratch or shift to unfamiliar industries. Instead, they can take what they are already producing and present it to a much larger market.

The Government e-Marketplace platform further supports this by organising these products into clearly defined categories. So, when a government department is looking to procure, say, office supplies or handloom items, it can easily find relevant products listed under Womaniya.

This structured approach also helps standardise listings, improve product presentation and build trust. Over time, it encourages women entrepreneurs to maintain quality, scale up production and think of their work not just as a small activity, but as a growing business with national reach.



Building Skills and Confidence

For many women, especially those starting out for the first time, using an online platform can feel a bit confusing at the beginning. Simple questions like *how to upload a product, how to decide the right price, or what buyers are looking for* often come up. To make this journey easier, regular training sessions, workshops and outreach programmes are organised across the country.

These sessions are designed to be simple and practical. Women are guided step by step on how to use the Government e-Marketplace, how to list and present their products properly, and how to meet quality standards expected by buyers.

With time, these small learnings add up. Women become more comfortable using digital tools, more confident in dealing with buyers, and more aware of how to run and grow their businesses.

Real Impact on the Ground

The impact of Womaniya is visible in the growing number of women entrepreneurs who are stepping into larger

markets and building stronger businesses.

Take the financial year 2025-26 as an example. During this period, more than 2.35 lakh women-led micro and small enterprises registered on the Government e-Marketplace. That means lakhs of women across the country - many from small towns and rural areas - are now part of a national marketplace.

And it does not stop at registration. These businesses are actively receiving orders. In the same year, around 14.2 lakh orders were placed with women-led enterprises. This shows that government departments are not only willing but actively choosing to procure from women entrepreneurs.

In terms of value, the impact is even more encouraging. Contracts worth over Rs. 31,000 crore were awarded to women-led businesses.

For many small enterprises, even a single government order can make a big difference - helping them expand production, hire more people and improve their quality of life.

Another important point is that women entrepreneurs accounted for 6.13% of total government procurement on GeM, going well beyond the 3% target set for such participation. This clearly shows that when given the right opportunity and support,

women entrepreneurs are not just meeting expectations- they are exceeding them.

These numbers reflect growing confidence, increasing participation and real economic progress. Behind every figure is a woman entrepreneur who is moving forward—building her business, supporting her family and contributing to the country's development.

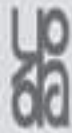

Women's Reservation Act 2023 Comes Into Force

The *Nari Shakti Vandana Adhiniyam*, formally known as the One Hundred and Sixth Constitutional Amendment Act, 2023, came into force with effect from April 16, 2026, marking a significant step toward greater representation of women in India's political domain. Passed by Parliament in 2023, the landmark legislation provides for one-third reservation of seats for women in the Lok Sabha and all State Legislative Assemblies, including Delhi, on a rotational basis. Parliamentary Affairs Minister Shri Kiren Rijju said the notification implements long-pending provisions and urged the Opposition not to politicise the move, calling it part of an ongoing process.

India, Austria Agree to Strengthen Ties across Key Sectors



India and Austria have agreed on ways to strengthen bilateral cooperation following talks between Prime Minister Shri Narendra Modi and visiting Federal Chancellor His Excellency Dr. Christian Stocker held in New Delhi on April 16. The discussions resulted in a series of agreements spanning defence,

trade, education, and technology. Key outcomes included an audiovisual co-production agreement to boost film collaboration and a Fast Track Mechanism to address business and investment challenges. In defence and security, both sides agreed to enhance military cooperation and set up a joint working group on counter-terrorism. They also signed an MoU on food safety and outlined initiatives in skills development and vocational training. Further areas of cooperation include road infrastructure, cybersecurity, peacekeeping, and space, along with strengthened startup collaboration under the India-Austria Startup Bridge and joint efforts in advanced technologies such as quantum technology and machine learning.

Rs. 1.53 Lakh Crore Rail Expansion Projects to Generate Large-Scale Jobs

Indian Railways has approved 100 expansion projects for 2025-26 with an investment of Rs. 1.53 lakh crore. The projects will cover over 6,000 kilometres of railway network and include new lines, doubling, and multitracking works. This massive expansion is likely to create jobs in construction, engineering, logistics, and related sectors, while also boosting demand for local industries and services. The projects are part of the PM Gati Shakti National Master Plan, aimed at improving connectivity and supporting economic development. In comparison, 64 projects were approved in 2024-25, covering around 2,800 kilometres. The latest approvals show a significant rise in both investment and route coverage. The projects will help decongest busy routes, improve train punctuality, and enhance passenger experience, while extending rail connectivity to underserved regions. Union Minister for Environment, Forest and Climate Change, Shri Bhupender Yadav termed the development a "milestone moment," noting that this is the first recorded wild birth involving an Indian-born cheetah since the programme began in 2022. Rs. 10,000 Cr Startup India Fund of Funds 2.0 to Boost Innovation

The government has introduced the Startup India Fund of Funds 2.0 with a corpus of Rs. 10,000 crore to improve access to funding for startups across the country. The initiative aims to strengthen India's startup ecosystem by increasing the flow of capital, especially in emerging and high-potential sectors. According to the Ministry of Commerce and Industry, the fund will invest in Alternative Investment Funds (AIFs), which in turn will support startups. Special emphasis will be placed on priority areas such as deep technology and early-stage ventures that often face challenges in securing funding. The Small Industries Development Bank of India

(SIDBI) has been designated as the implementing agency and a Venture Capital Investment Committee will oversee investments. The initiative is expected to play a key role in driving innovation-led growth, strengthening manufacturing, creating high-quality jobs, and positioning India as a leading global hub for startups and technology development.



7th Critical Mineral Block Auction Launched

The government has launched the 7th tranche of critical mineral blocks along with the 2nd tranche of exploration licences to strengthen India's mining sector and ensure access to key resources. A total of 19 mineral blocks are being offered, including important minerals such as lithium, tungsten, and tin. These resources are essential for industries like clean energy, electronics, and advanced manufacturing, making them crucial for building strong domestic supply chains. Both central and state authorities are working to streamline approvals and create a more investor-friendly environment in the mining sector. The initiative is expected to reduce import dependence, support industrial growth, and advance India's goal of becoming self-reliant in critical minerals.

INTERNATIONAL

US Senate Rejects Plan to Pull Out of Iran Conflict

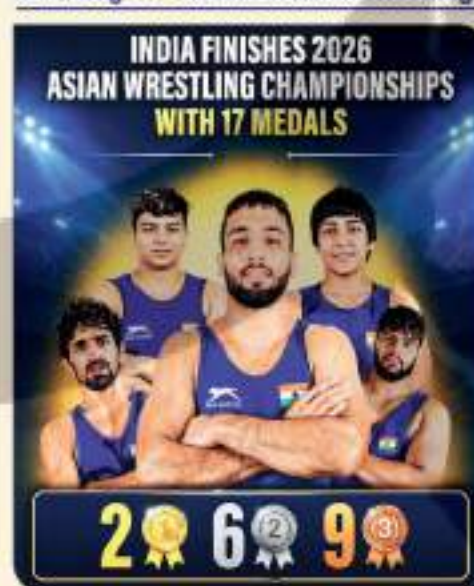
The US Senate has voted against a proposal to withdraw American forces from the Iran conflict. The resolution, brought by Democrats, aimed to limit President Donald Trump's authority to continue the war without Congress's approval. The proposal was defeated by 47 votes to 52. This is the fourth time this year that the Senate has allowed the president to keep control over war decisions. According to the War Powers Act of 1973, the president must get approval from Congress within 60 days of starting a conflict. As this deadline is expected by the end of April, lawmakers have asked the government to clearly explain its plan for ending the conflict.

IMF Halts Bangladesh Loan Tranche

The International Monetary Fund (IMF) has delayed releasing a 1.3 billion US dollar loan tranche to Bangladesh, citing slow progress on key economic reforms. Officials said the IMF is not ready to continue with the current 5.5 billion US dollar programme without a full review. Instead, it is proposing a new deal with stricter conditions. About 1.86 billion US dollars is still left under the programme, which runs until 2027. The IMF pointed to weak progress in areas like tax collection, banking reforms, subsidy cuts, and exchange rate changes. Some recent policy decisions have also raised concerns. Experts warn the delay could affect Bangladesh's chances of getting funds from other global lenders, especially as the country faces rising import costs and pressure on its foreign exchange reserves.

SPORTS

India Bags 17 Medals at Asian Wrestling Championships



India wrapped up a strong campaign at the Asian Wrestling Championships in Bishkek, finishing with 17 medals—two gold, six silver, and nine bronze. On the final day, Aman Sehrawat secured silver in the men's 61 kg freestyle after a narrow 10-13 loss to South Korea's Kwang Myong Kim. Mukul Dahiya also claimed silver, going down 0-7 to Iran's Kamran Ghasempour in the 86 kg final. Dinesh added a bronze in the 125 kg category with a dominant 12-1 technical win over Kyrgyzstan's Arslanbek Turdubekov. India's medals were spread across disciplines, with seven in men's freestyle, five in Greco-Roman, and five in women's wrestling, highlighting depth across categories.

Vaishali Wins FIDE Candidates, Eyes World Championship

India's Grandmaster R. Vaishali has won the FIDE Women's Candidates Tournament 2026 in Cyprus, securing her place in the upcoming World Championship. The 24-year-old defeated Russia's Katerina Lagno in the final round to finish with 8.5 points from 14 games. With this victory, Vaishali will now challenge reigning champion Ju Wenjun later this year. In the Open section, Uzbekistan's Javokhir Sindarov claimed a dominant win, finishing on 9.5 points—two ahead of Anish Giri of the Netherlands. Sindarov will face current world champion D Gukesh in the title match.
